Daniels moved; Wallace 2nd; the Board voted to approve the manifest dated March 2, 2020 for payroll/accounts payable in the amount of \$ 14,830.99 for the week of, February 21, 2020-February 27, 2020.

Received letter to the Selectmen from a resident on Lang Road. The resident would like to commend Road Agent Buddy Blood and all who may have helped him for the nice job maintaining Lang Road during this winter. Road was plowed wide and sand was spread in a timely manner on all icy spots. Read.

Letter from Monadnock Family Services stating due to the reduction of funding from the Monadnock United Way effective April 30, 2020 the following four programs are included in the funding cut: Emergency Services, Substance Abuse Services, the Monadnock RSVP Volunteer Center and the new Neighbor to Neighbor program that started in January 2020. Read.

Received Building Permit for Map 407 Lot 040. All Board members had visited the property separately. Permit is being held due to zoning violations and lack of septic plan. Harrington to follow up with resident to schedule appointment with Board.
