Meeting opened at 5:35 pm

Wallace moved; Daniels 2nd; Board voted to approve the manifest dated February 28, 2022 for week of February 18, 2022-February 24 2022 in the amount of: \$ 5,970.58 for payroll/accounts payable.

Bersaw moved; Wallace 2nd; Board voted to approve Building Permit for Map 415 Lot 008-560 Whipple Hill Road. Owner-Sul.

Wallace moved; Bersaw 2nd; Board signed the resolution of intent to join the National Flood Insurance Program.

Daniels signed rental application for the Veteran's Memorial Hall on April 2, 2022.

Wallace moved; Daniels 2nd; Board approved Intent to Cut for Map 402 Lot 027. Owner-Hodgman.

Daniels signed application for payment from the Bridge Improvement Fund in the amount of \$23,935.22 to be deposited into the General Fund. The payment of \$23,935.22 to Quantum Construction Consultants, LLC for invoice #2981 was paid from the General Fund on 02/18/2022.

The New Hampshire Department of Environmental Services sent Administrative Completeness Notice-Standard Dredge and Fill Wetlands Permit Application (RSA 482-A) for Tully Brook Road NHDES File number 2022-00334.

Board reviewed the Notice of Decision for Lauren Shearer's Road Layout Petition. Daniels moved; Wallace 2nd; Board voted to sign the Notice of Decision denying the petition. Harrington to give Notice of Decision to the Town Clerk to be recorded and kept as part of the permanent records of the town.

Email from Alison Van Brocklin stating the Richmond Community Church would like to provide refreshments during the Town Meeting on Saturday, March 12th as they have done in the past. All donations support the Richmond Food Pantry. Board agreed to allow. Thompson will contact Alison Van Brocklin.

Board discussed Selectmen coverage for the March 8, 2022 election. Daniels moved; Bersaw 2nd Board appointed Jennifer Thompson and Susan Harrington as Selectman Pro Tem for the duration of the March 8th Town Election. Terms to expire on March 9, 2022. Board also appointed Susan Harrington as the Keeper of the 250th cane. Term to expire March 31, 2023.

Bealzy Auto contacted the office to schedule a time for the Board to view his property for his business permit. Harrington will contact Bealzy Auto to schedule a time for Selectman Bersaw and Selectman Wallace to meet with him.

Richard Drew met with the Board to discuss a ditch on Tully Brook Road. There is a blocked culvert at 210 Tully Brook Road. Drew would like the ditch cleaned out. Harrington to contact Road Agent to advise of blocked ditch.

Doug Smith, Chairman of the Broadband Committee met with the Board to discuss the expectations of the Broadband Committee. Discussed progress being made, possible options for grants in the future. Also discussed a town wide survey that the Broadband Committee put together, information will be distributed at the 2022 Town Meeting and in the Richmond Rooster. Chairman Smith urged that everyone should complete the survey especially if they use the internet for work or educational purposes.
