Amendment to April 23, 2018 minutes

Delete sentence: The Board of Selectmen elected to participate prospectively in the New Hampshire Retirement System's tax shelter program under the provisions of RSA 100-A:16.

The Board reviewed the materials sent by New Hampshire Retirement System for town participation in the system with regard to hiring a permanent full-time police officer, Cameron Prior.
