*****Administrators Report**

Wood advised that she has discussed the set-up of the Vets Hall with the Road Agent for both the Pre-Warrant, scheduled for 1/28/16, as well as set up for the Presidential Primary.

The Treasurer's position will change from elected to appointed in March, as voted last Town Meeting. Wood has spoken with the current Treasurer and she would like to continue.

Bill Coll was inquiring the status of the Quaker Cemetery. He shared a letter he received from Dorothy Zug in regards to the cemetery. Wood shared letter with the Board.

Wood discussed the draw down on the Line of Credit with Savings Bank of Walpole for the upgrade of Fay Martin Road. After reviewing all invoices and payments (Saint Benedicts contribution of \$50,000.00 and transfers from the Capital Reserve Road Reconstruction fund) the amount to drawn equals \$144,605.91. The Line of Credit matures 2/4/16 so the request needs to be finalized asap. Wood to submit the request once amount is approved by Board.

Wood advised that Senator Ayotte's representative will be here on Thursday, 1/28/16 to hold office hours from 10:30a-11:30a for any resident who would like to speak with them. The event is posted on the website.
