Selectmen's Meeting Minutes

**Meeting:**

Mail opened and reviewed.

Gillis updated the Board on the repairs to the Vet's Hall ramp that took place over the weekend. The ramp was power washed and a non-skid paint applied in an effort to improve the ramp.

The Board reviewed resumes received for the Deputy Tax Collector's position in preparation for discussion with the Tax Collector.

McWhirk moved; Gillis 2<sup>nd</sup>; the Board voted to approve the payroll/accounts payable dated Nov. 3, 2014, for period of Oct. 28-Nov. 3, 2014, in the amount of \$10,897.35.

Jameson moved; Gillis 2<sup>nd</sup>; the Board voted to appoint Stillman Rogers as Inspector of Elections, term to expire July 31, 2016.

Jameson moved; Gillis 2<sup>nd</sup>; the Board voted to appoint Richard Lewis as Inspector of Elections, term to expire July 31, 2016.

The Board reviewed the equalization documents from Avitar and signed the necessary documents for the DRA.

Jameson moved; McWhirk 2<sup>nd</sup>; the Board voted to approve the Yield Tax for M402 Ls 043, 044 045.
