Bersaw moved; Daniels 2nd; Board voted to approve the manifest dated April 25, 2022 for week of April 15, 2022-April 21, 2022 in the amount of: \$ 4,291.87 for payroll/accounts payable.

Bersaw moved; Daniels 2nd; Board approved the reappointment of John Lewis as a Cemetery Trustee Alternate. Term to expire 03/25/25.

Daniels moved; Bersaw 2nd; Board approved the renewal of building permit #2021-011 for Map 407 Lot 095.

Daniels moved; Bersaw 2nd; Board approved Intent to Cut for Map 407 Lot 083.

Daniels signed application for payment from the Fire Truck Fund to reimburse the general fund \$ 27,000 for the purchase of a 2016 Chevy Tahoe.

Letter from the NHDOT regarding the Whipple Hill Road over Roaring Brook-BR. #065/083. The NHDOT has approved the engineering study submitted by Quantum Construction Consultants. The NHDOT is currently reviewing a revised design scope and fee and adjusted efforts required to move project construction funding to federal funds. The NHDOT is will be carrying the anticipated project costs that could total \$1,683,384.36.

Letter from Avitar Associates of New England, Inc. received recommending the abatement request from PSNH be denied. Harrington forwarded to attorney.

Letter of appreciation received from the Hundred Nights Inc. Emergency Shelter & Open Doors Resource Center to the Town of Richmond for the 2022 contribution of \$1,000. Letter attached.

Letter of appreciation received from the Community Volunteer Transportation Company to the Town of Richmond for the 2022 contribution of \$100. Letter attached.

Board reviewed email from Lt. Caleb Dodson responding to questions Board inquired regarding overlapping hours of coverage on March 2022 statements.

Board reviewed estimate for Taylor-Van Brocklin Municipal Building sign. Board agreed to accept estimate from Gem Graphics. Harrington to contact Gem Graphics.

Email from resident stating she and another resident are interested in becoming members of the Parks and Recreation Commission. Harrington to contact potential members to meet with the Selectmen.

Bersaw moved; Daniels 2nd; Board voted to allow Selectmen Bersaw to negotiate a loan for the bridge but not to conclude the agreement or to sign any documents finalizing an agreement. Bersaw will submit all paperwork to the Selectboard. Harrington to provide Savings Bank of Walpole with documents regarding the bond.

Appointments

Richmond Zoning Board of Adjustments Chairman, Alan Schmidt and Vice Chairman, Marcus Beauregard met with the Board to discuss the responsibilities of the Zoning Board. Daniels asked if they were here on behalf of the whole ZBA Board, A. Schmidt confirmed they are not. Bersaw stated the Select board will seek potential members themselves, suggests that if the ZBA has an interested resident, they should refer them to the Select board. Daniels stated that they would recommend to any interested party to sit in on a ZBA meeting to learn the ins and outs of how it functions. At this time, there are no pending ZBA meetings. Bersaw stated Tom Tague would work with Kim Mattson to set up recordings for the Zoning Board of Adjustments.

Mr. Yvon Brulotte met with the Board to discuss his driveway on Fish Hatchery Road. Mr. Brulotte is having issues with his driveway and ditches flooding. Board requested Harrington to schedule appointment with Road Agent for next meeting.

Meeting adjourned at 7:10 p.m.


